**Sub: Dearness Relief on Pension / Family Pension**

As per Para 10 of Rule 37 - of the CCS (Pension) Rules 1972, in addition to pension or Family Pension, as the case may be the pensioners shall also be eligible to the Dearness Relief as per Industrial Dearness Allowance (IDA) pattern the percentages of which payable from 01.04.2009. and onwards are given below: - The Dearness relief on IDA Scale is applicable to BSNL Retires / BSNL Family pensioners only"
